

Heidelberg (Dover NH) Buys Gas via Usource

Hampton, NH – July 5, 2000: Usource L.L.C. (www.usourceonline.com), a subsidiary of Unitil Corporation (AMEX:UTL), today announced a successful natural gas purchase for Heidelberg Web Systems Business Group Headquarters in Dover, New Hampshire. The one-year purchase of approximately 37,000 dekatherms demonstrates the value of exchange-based trading via the Usource Internet auction process even in a challenging market.
