- Includes 66,779 shares of common stock acquired on February 25, 2022, 58,250 shares of common stock acquired on May 27, 2022, 59,616 shares of common stock acquired on August 26, 2022 and 63,039 shares of common stock acquired on November 28, 2022, in each case resulting from the reinvestment of dividends pursuant to Unitil Corporation's Dividend reinvestment and Stock Purchase Plan.
- Shares may be granted pursuant to the Unitil Corporation Second Amended and Restated 2003 Stock Plan. Any such shares would be granted after a three-year performance period based on the attainment of certain performance thresholds of certain performance goals. Any such shares would be valued at current market price on date of grant.
